Financial

- Joan and I spent nearly ½ a day on Wednesday, January 10th going over the budget, operating funds and financial organization of the library. Time well spent and looking forward to more administration time with her.
- All bank documents relating to my position as Director have been signed by myself and the board, and have been returned to Greene County Bank.

Collection and Circulation

- OverDrive saw an overall increase in digital circulation, readers and new users for the 2022 to 2023 comparison. Checkouts up 13.9%, new users up 29%, and readers up 18.3%
- Attached are physical circulation stats for Catskill and Palenville annually, including YoY comparison to 2022 Some notable mentions would be:
 - YoY increases in new users (10.46% Catskill; 8.51% Palenville).
 - YoY increases in total users (26.44% Catskill; 26.50% Palenville).
 - YoY decrease in physical items circulating (-5.25% Catskill; -24.57% Palenville).
 - Average Daily circulation for 2023 for Catskill is 107 and for Palenville is 42.

Programs and Services

 Met with Ben from Village of Catskill Community Solar, who will be holding 'Office Hours' on Saturday, February 17th from 10 am to 2pm. Library will be fully marketing the program, and our goal is to get Ben the needed three sign-ups the village needs to receive a \$5k grant for climate initiatives from the state.
